All activities of the Air Cadet Program are funded either through the Department of National Defense (DND) or through the active fund raising efforts of the members of the Squadron Sponsoring Committee assisted by the Cadets.

111 Pegasus Squadron Sponsoring Committee pays costs such as facility rentals for activities outside the Armoury, website expenses, familiarization flying costs, certain extra-curricular activities, band instruments, insurance, volunteer screening, award trophies & plaques, cadet dinners and other activities not covered by DND.

The Air Cadet League of Canada, British Columbia Provincial Committee cover the costs of the maintenance and insurance for gliders and tow planes, volunteer insurance through ACL of Canada, BCPC office and administration costs, and legal services retained for the benefit of BCPC and Sponsoring Committees.

Each year parents are requested to pay an Assessment fee to help offset the operating costs identified above. This fee is composed each year of a BCPC Assessment and a 111 Pegasus Squadron Sponsoring Committee Assessment. The SSC has a financial support policy in place and no cadet will be turned away if their family is unable to pay the SSC Assessment. If this Assessment creates a financial barrier to registering for the 111 Pegasus Squadron please contact the SSC Chair (chair111air@gmail.com) for a confidential discussion regarding this challenge. Throughout the year, **parents are also requested to help in various ways** to help maintain the high level of activities planned for the training year.

There are many advantages that your child receives as a member of the cadet program. All uniforms are provided by DND, cadets have the opportunity to participate in the band, first aid, drill team, effective speaking and weekend exercises. In addition, cadets who attend various summer camps and scholarship camps do so at no or minimal cost to the parents; in fact, cadets who are selected for a summer camp receive a "Training Bonus" while at camp!
